Responding compassionately to meet needs and support community recovery

As the uncertainties of COVID-19 began to unfold in early 2020, one thing was clear: Responding to this unprecedented event would require a collaborative effort unlike ever before. **Our community was up to that challenge.**

In partnership with Spokane County United Way, Empire Health Foundation, Avista Foundation, Equinox Foundation, Lewis-Clark Valley Healthcare Foundation and generous contributions from many other funders, we launched two COVID-19 Community Response & Recovery Funds to serve our region's most vulnerable populations during the pandemic.

Within the first four months of the pandemic, a massive influx of dollars from donors and funders across the region resulted in grant distributions totaling \$1.5 million to organizations providing direct support in response to COVID-19. These included many grassroots, neighborhood, and culturally specific groups that are trusted partners in their communities.

As we transitioned from response to recovery, a third round of grants encouraged collaborative partnerships aimed at innovative solutions to accelerate recovery and build resilience.

Through our COVID-19 response efforts, we learned that trusted community messengers are in the best position to help those who need it the most, but those trusted partners may not be the 501 c3 organizations we have typically funded. Instead, they are small, grassroots, culturally specific and neighborhood-based organizations that are often run by volunteers. It has been our privilege to support the efforts of these groups to reach the most vulnerable and disproportionately impacted by the pandemic.

We have also learned the tremendous value of working in collaboration with other partners. Pooling philanthropic dollars and leveraging the grantee relationships of multiple funders allowed us to reach many more grantees than any one of our organizations could have reached on our own. Without these partnerships, our response and recovery grantmaking effort would not have been possible.

Thank you to our partner funders, individual donors, community volunteers and the organizations working tirelessly to meet the challenges that this pandemic has created. We look forward to continued collaboration and working together to build resiliency and hope in communities throughout our region.


DISTRIBUTED TO COMMUNITY ORGANIZATIONS IN GRANT ROUNDS 1, 2 & 3

ROUND 1: In April 2020, we worked with community volunteers to proactively identify those organizations best positioned to provide direct support in response to COVID-19.

ROUND 2: A second round of funding in June continued to focus on basic needs, with a more intentional focus on getting dollars to grassroots, neighborhood, and culturally specific groups.

ROUND 3: As we transition from response to recovery, a third grant round awarded \$1.3 million to support organizations working to meet basic needs, along with collaborative partnerships aimed at innovative solutions to accelerate recovery and build resilience.

Other COVID-19 Relief

Supporting historically underrepresented people within our communities

We understand that COVID-19 disproportionately impacts communities of color. Through our COVID-19 grants, we are working to be more responsive to disparities experienced by Black, Indigenous and People of Color (BIPOC). To date, more than \$650,000 has been directed specifically to BIPOC communities.

Our region is home to **six tribes**, with many Native Americans living in communities that are not on the reservations. Tribal health leaders came together with regional funders to direct flexible resources to their COVID-19 response.

“Ninety percent of the estimated 10 million Tribal peoples in what is now called the continental United States lost their lives to colonization-related epidemic between the 15th and 17th centuries. European spread diseases such as smallpox, influenza, and tuberculosis decimated entire Tribes, their families, cultures, and languages,” says **Shivon Brite (Nakota), Empire Health Foundation Executive Vice President.**

And now the spread of COVID-19 is affecting American Indians and Alaska Natives at a rate 3.5 times higher than non-Hispanic whites. Further, this pandemic is especially deadly for our Tribal peoples because of pre-existing health and socioeconomic disparities caused by persistent racial inequity and historical trauma. In response, Tribal health leaders have come together in partnership with Empire Health Foundation and Innovia to self-direct flexible COVID-19 resources to their communities,” concludes Brite.



VETERANS OF FOREIGN WARS WOMEN'S AUXILIARY POST 8311 Providing meals to vulnerable residents through COVID-19 Response and Recovery Grant

Veterans of Foreign Wars (VFW) Women's Auxiliary Post 8311 received a \$2,500 COVID-19 Response and Recovery Fund grant to assist them in meeting an increased need for food and home deliveries for senior, disabled, home-bound and low-income citizens within a 100-mile radius of Elk City, Idaho. “As a result of this arrangement, not only were we able to provide for our residents in need, but helped our local businesses as well. The restaurants and the general store greatly reduced their prices for meals and groceries, which allowed us to provide for more people for a longer period of time,” said Sharon McKee, the president of VFW Women's Auxiliary.



NAMI FAR NORTH Addressing the Mental Health Crisis

The stress and uncertainty of the COVID-19 pandemic have left many in need of mental health support. The National Alliance on Mental Illness (NAMI) Far North seeks to raise awareness about mental health needs and to support those in Bonner and Boundary counties who find their lives disrupted by mental health challenges. A \$5,000 grant from Innovia helped staff North Idaho Crisis Services (NICS), an after-hours crisis line that serves as a first point of contact for residents experiencing an emergency. The grant also funded an expanded campaign to advertise mental health services available to the community, helping to ensure that every individual has the resources they need to pursue a better quality of life.

HAPPY HORIZONS CHILDCARE

Grant ensures wellbeing of children and parents coping with the crisis

Even with steady employment, many families are challenged to provide basic necessities. Single parents spend, on average, 36% of their income on childcare, and that often does not leave enough to pay the bills or buy nutritious food, especially for those living paycheck-to-paycheck. The COVID-19 pandemic has severely exacerbated these needs. Happy Horizons Childcare in Moscow, Idaho provides affordable daycare for ALICE families (Asset Limited, Income Constrained, Employed). With the help of Happy Horizons, parents no longer have to choose between going without childcare or going without dinner. The program gives children age-based curricula, two nutritious meals per day and a healthy place to play with other children. With normal activities on pause during the crisis, Happy Horizons received a \$10,000 grant from Innovia Foundation as flexible funding to promote and help support financial stability for low-income households. The ultimate goal is to interrupt the generational cycle of poverty and improve the economic wellbeing of our entire community. It starts with meeting the fundamental needs of vulnerable populations, ensuring that every person can pursue their potential without worrying about their next meal.

COMMUNITY ACTION CENTER

Shelter in the Storm

In a city where university students are critical to the economy and rental properties constitute 65% of total housing, the pandemic quickly created an affordable housing crisis for many Pullman residents. Thanks to a \$10,000 COVID-19 Response and Recovery grant from Innovia, the Community Action Center was able to support a Housing Solutions Program that provides emergency housing assistance and eviction prevention. Additional grant dollars from Innovia also have enabled the Center to meet increased demand for emergency food through participation with Pullman Serves It Forward. That partnership leveraged an additional \$37,000 in community donations to purchase gift cards from local restaurants to distribute to food bank clients. It demonstrates how the right strategic partnerships can maximize donors' dollars and amplify their reach, in this case by benefitting both local residents and local businesses.

CARL MAXEY CENTER

Bridging Divides

The Carl Maxey Center in Spokane is dedicated to changing lives and improving the well-being of Spokane's African American community. Early in the COVID-19 pandemic, when many Black-owned businesses closed under the statewide stay-at-home order, the Center recognized the need to provide targeted assistance directed specifically at the community they serve. A \$20,000 grant helped the Carl Maxey Center hire a part-time, temporary community support position to focus on meeting the unique needs of African American business owners, most them small sole-proprietorships facing a disproportionately higher risk of not being able to survive the shutdown. "The loss of these businesses would be devastating for our community, says Sandra Williams, Executive Director of the Carl Maxey Center. "This grant acted as both a safety net to keep our businesses from losing ground and as a bridge to get us through the COVID-19 crisis to the other side."



BLUE MOUNTAIN ARTISANS GUILD

Sparking Kids' Creativity

During a summer when the pandemic significantly reduced vitally needed enrichment activities for children, a \$1,000 grant from Innovia enabled the Blue Mountain Artisans Guild (BMAG) to offer a curbside pick-up art program for youth who live in the rural wheat farming communities of southeastern Washington. The program provided children ages 2 to 17 with take-home summer art bags that included a variety of activities such as clay modeling, drawing, painting and scratch art. As a result, kids were able to spend seven weeks with fun and enriching art projects that sparked their creativity, nurtured their boundless imaginations, and enhanced their confidence and problem-solving skills. An 11-year-old girl from Pomeroy was among the kids experimenting with different art forms thanks to the program. She returned to the BMAG Art Center at the end of the summer with stacks of her artwork and was featured as the Junior Artist for the Fall Fantasies Art Show held in September.



COVID-19 NEEDS


In March 2020, 1,220 community members were surveyed, representing residents and 170 different community organizations. More than one-third of the respondents listed the following as top priorities for funding.
