Letter of Authorization

- 1. Use this form to request a QCD from your IRA.
2. Send to your Financial Advisor
3. Send a copy of this completed form to Innovia Foundation
4. Financial Advisor will follow your instructions to give your QCD to Innovia Foundation which is a 501 (c)(3) charitable organization eligible to receive tax deductible contributions.
5. The distribution must be made payable directly to Innovia Foundation. Please have the fund name listed on the memo line. Your financial institution will issue a check made payable to Innovia Foundation and should be mailed directly to Innovia Foundation (address above).
6. QCD's will count towards your annual IRA required minimum distribution (RMD) for the year distributed. For a QCD to qualify as your annual RMD, the funds must be distributed by your RMD deadline, December 31st, please allow for processing time.
7. QCD's are not subject to tax withholding.
